




### Legislative Drafting: Beyond Words

Author: DT Adem

Words can be problematic as they have different meanings and shades. Depending on the context in which they are used, they may be ambiguous and vague. The drafter therefore has to go beyond words while drafting a piece of legislation because, in modern drafting, clarity, accessibility, precision and unambiguity of the legislation are the primary concerns of the drafter and the interest of the audience.

*Legislative Drafting: Beyond Words* suggests the use of other devices to counter this challenge in a bid to aid the drafter in making legislation easy to understand. These devices are very useful, as they improve the understanding of the legislation by the audience, reduce litigations, increase the level of compliance as well as make them user-friendly.



### Legislative Drafting: Forbidden Devices

The drafter of legislation does not merely “draft”, but employs some legislative devices in order to produce a piece of legislation that is accessible, clear, intelligible and effective. Consequently, a drafter is obliged not to use any device that will make legislation inaccessible, unclear, unintelligible and ineffective.

*Legislative Drafting: Forbidden Devices* therefore focuses on the devices that a drafter must avoid or use with care when drafting a piece of legislation.



### Legislative Drafting: Making a case for the Audiences

For legislation to be effective the drafter must first have in mind the people or group of people the legislation is to govern in order to employ appropriate language and communicate clearly and effectively.

While drafting legislation, drafters often make a common mistake: they do not see the audience of the legislation as ordinary citizens but rather as elite and consequently their writing tilts towards the elite. Until recently, the language employed by drafters did not contemplate an ordinary citizen or a person with average education and this resulted in their making the legislation not accessible to the ordinary citizen.








### Code Civil Mauricien

The French Civil Code was extended to Mauritius under the title Code Napoléon by decree of Decaen, Capitaine- General, on 21 April 1808. This Code was modified and embodied in Chapter 179 of the Revised Laws of Mauritius 1945, edited by Sir Charlton Lane, former Chief Justice of Mauritius. The 1808 decree was repealed by Act 9 of 1983 but the Revision of Laws Act which was enacted in 1974 made provision, in section 7, for the publication of the Code under the title "Code Civil Mauricien". This edition (in French) was updated to 2012, and incorporates a table of references to reported cases in the Mauritius Reports.
